

CLIENT RESPONSIBILITIES

1. By affixing his/her signature or the signature of all persons designated for the duration of the contract, the client (individual or company) agrees to respect this contract in full. The contract will end when the equipment and accessories are returned.
2. Under no circumstances can the client rent out, lend or mortgage the rented/loaned equipment and accessories.
3. The client frees the Renter of all responsibilities with regard to damages, broken equipment or accessories, loss of data or any other problem that may be caused by the use of the rented/loaned property.
4. The client must notify the Renter in writing of any operating defects found in the rented/loaned equipment and accessories so that the latter can make arrangements with the client as soon as possible.
5. The client agrees to return the rented/loaned equipment at the end of the rental period in the same condition (appearance and operating condition) in which it was received, taking normal wear and tear into account.
6. The client agrees to pay the Renter an amount equal to the cost of repairing or replacing the equipment and accessories (new value), as the case may be, if the Renter deems that the returned equipment and accessories have been damaged.
7. The client agrees to pay the Renter the new value of unreturned equipment and accessories that have been lost. The client must pay the invoice according to the Renter's terms and conditions.
8. The client agrees to pay the Renter a penalty if the equipment and accessories are returned late.
9. The client is required to use protective screens at all times when using the lighting sets. The Renter disclaims all responsibilities or damages that could be incurred by incorrect use of the lighting sets.
10. If the client violates any of the above-mentioned conditions, the contract will automatically be terminated without requiring a formal demand or legal proceedings, for all legal purposes. It will also give the Renter the right to take possession of the equipment and accessories without having recourse to legal proceedings.
11. The client cannot terminate the obligations of this contract until the Renter has received full payment of all due amounts directly or indirectly tied to this contract.
12. Under no circumstances can the client free himself/herself from these responsibilities in another manner.
13. The Renter can take back the equipment and accessories without losing the right to claim the client's rental fee as well as damages incurred by the client by not respecting the aforementioned conditions.
14. If the Renter must retain the services of a lawyer to make the client respect his/her obligations, said client will be required to pay an equivalent of 20% of the unpaid amount claimed in order to bear the extra-judicial and other taxable fees.
15. The Renter has the insurance coverage needed to replace the equipment at new value in case of loss or risk of damage including breakage during this contract. Said insurance also covers indirect damage to the Renter if the equipment is not available for an extended period and the Renter can show that a loss occurred.

Certificate of Insurance

1. The client must inform the Renter when planning to use the rented/loaned equipment and accessories outside of Canada. If that is the case, the client must submit proof of insurance naming The Camera Department as the beneficiary.
2. The client must confirm to the Renter that he/she has "all-risk insurance" and is therefore responsible for all loss or damage caused to the equipment and accessories. The client agrees to notify the Renter by registered mail within 24h of any incident involving fire, theft, breakage in whole or in part or seizure of the rented/loaned equipment and accessories.
3. In the event of theft, the client must submit a police report describing the equipment and accessories as well as all circumstances surrounding the incident in which the loss or damage occurred.
4. The Renter can require proof of insurance attesting that the rented/loaned property is adequately covered during the rental period.

The Client states that he/she has read and accepts the conditions set out in this contract.
